<u>Demand Occupations Policy</u>

Chair, Green Country Workforce Development Board

No individual in the United States may, on the basis of race, color, religion, sex, national origin, age, <u>disability</u>, or political affiliation or belief, or, for beneficiaries, applicants, and participants only, on the basis of citizenship or participation in any WIOA Title I-financially assisted program or activity, be excluded from participation in, denied the benefits of, subjected to discrimination under, or denied employment in the administration of or in connection with any WIOA Title I-financially assisted program or activity.

Purpose

To provide guidance and make a determination of the occupations that have a substantial current or potential impact on the economy of Green Country.

Policy

The authority to make this determination is explicitly stated in Section 3(23)(B) of WIOA as, the determination of whether an industry sector or occupation is in demand shall be made by GCWDB using State and regional business and labor market projections, including the use of labor market information.

The Green Country Workforce Development Area (GCWDA) encompasses an 11-county region in Green Country including:

Adair	McIntosh	Osage	Tulsa
Cherokee	Muskogee	Pawnee	Wagoner
Creek	Okmulgee	Sequoyah	

Demand occupations have been determined based on job opening data collected using the following resources:

- Oklahoma Employment Security Commission (OESC),
- Oklahoma Office of Workforce Development (OOWD) Workforce Area Briefing,
- Other data collecting tools such as Economic Modeling Specialists, Inc. (EMSI),
- And by incorporating employment trend data and review of current WIOA approved Eligible Training Providers.

In addition to the specific skills needed for each position, local employers and the workforce development board have determined that job readiness and other "soft skills training" will be necessary in order to reduce employee turnover and associated training costs. Job readiness and other soft skills training, regardless of the necessity, are not approved occupations/skills trainings for development of an Individual Training Account. These skills must be attained via a Green Country Works Center or other appropriate partner.

The GCWDB has chosen to approve occupational codes/job families within the targeted industry clusters as identified by OESC, OOWD, GCWDB and EMSI. Job families are groups of occupations based upon work performed, skills, education, training and credentials, for example: 53-3032.00 Heavy and Tractor-Trailer Truck Drivers job family code is "53".

The O*NET occupational codes begin with a two-digit number, which coincides with the above approved list. Therefore, all occupations that have a two-digit code from the above list are approved as a demand occupation with exception of specific exclusions and inclusions as noted. Prohibited Industry

In accordance with federal law, WIOA funds **MAY NOT** be used to support the marijuana industry including directly or indirectly, but not limited to use, possession, growth or distribution of marijuana. Additionally, medical marijuana facility occupations ARE NOT occupations in which a local area can place an individual.

Authorization for Clarifications and Additions

GCWDB authorizes the GCWDB Executive Director to issue additional instructions, guidance, approvals and/or forms to further implement requirements of this policy, without making substantive change to the policy except in situations where new or updated State and Federal guidance is issued.
