- **Oklahoma Works Engages with Job Seekers at Green Country Technology Center Career Fair**



On Friday, May 2, 2025, Green Country Technology Center in Okmulgee held its annual Career Connection Career Fair, bringing together students, job seekers, and employers from the region.

Sheri Friend, representing the Oklahoma Works office in Okmulgee, attended the event and connected with participants to discuss career pathways, training opportunities, available services, and current job openings in and around the Okmulgee area.

Career fairs like this one play a vital role in helping individuals take the next step in their professional journey. Many attendees were not only exploring employment options but also considering meaningful life and career changes. Oklahoma Works is proud to support community events that empower individuals to pursue rewarding and sustainable careers.

- **OK Commerce Dept launches education, workforce incentive**



The Oklahoma Department of Commerce has launched its first Public-Private Partnership (P3) incentive for Education and Workforce Development, partnering with Northern Oklahoma College (NOC) in Enid to build a new Athletic Training and Education Center. This initiative aims to strengthen Oklahoma's workforce pipeline by addressing the growing demand for athletic trainers and

pre-healthcare professionals. The \$675,000 P3 award, combined with NOC's \$1.5 million investment, will enable the facility to serve an additional 27 students in allied health and athletic training programs. The project, set for completion in 2026, will enhance workforce development through partnerships with Enid Public Schools, Great Salt Plains, and St. Mary's. This effort underscores Oklahoma's commitment to fostering economic growth through targeted education and workforce initiatives.

## Oklahoma Legislative

- **Senate Committee Warns HHS Budget Cuts Threaten Native Health Services**

- The Senate Committee on Indian Affairs has raised serious concerns about Department of Health and Human Services (HHS) budget cuts and staff reductions that are harming Native health programs. Tribal leaders and lawmakers argue that the reorganization—resulting in job losses and agency consolidations—has led to reduced access to vital services without proper tribal consultation. Programs like Healthy Tribes and SAMHSA have been downsized or eliminated, further weakening local support networks. Lawmakers stress that such cuts violate federal trust responsibilities and are urging HHS Secretary Robert F. Kennedy Jr. to consult directly with Native communities before implementing further changes.

- **Gov. Stitt signs Oklahoma personal income tax cut into law**

- Governor Kevin Stitt signed House Bill 2764 into law on May 29, 2025, reducing Oklahoma's personal income tax rate from 4.75% to 4.5% and consolidating the state's six tax brackets into three, setting a path toward eliminating the income tax. The legislation, authored by Rep. Trey Caldwell and Sen. Chuck Hall, includes a trigger mechanism to further reduce the rate by 0.25% increments when revenue benchmarks are met, ensuring fiscal responsibility with safeguards to protect core services if revenue falls. This tax cut aims to simplify the tax code, boost economic competitiveness, and encourage business growth in Oklahoma. Senate President Pro Tempore Lonnie Paxton and House Speaker Kyle Hilbert emphasized the plan's role in fostering long-term prosperity while maintaining \$3.5 billion in state savings.

- **Firehawk rocket motor manufacturer building facility in Oklahoma**

- Firehawk Aerospace, a Dallas-based company, is investing \$22 million to build a 40,000-square-foot manufacturing facility in Lawton, Oklahoma, creating 100 jobs by 2028. The facility, the first scaled 3D-printed rocket propellant factory in the state, will produce rocket fuel in six hours, compared to the traditional 15-60 days, enhancing efficiency and supporting national defense. Located near Fort Sill and supported by a \$4 million state tax incentive, the plant will leverage Oklahoma's business-friendly environment and proximity to military bases. This development strengthens Oklahoma's role as a defense hub through the FISTA network, with potential for future expansion on an additional 160 acres.

- **Childcare bill now Oklahoma law after legislature overrides Stitt veto**

- The Oklahoma Legislature overrode Governor Kevin Stitt's veto of House Bill 2778, which provides no-cost childcare to early childhood educators to address the state's childcare crisis. Authored by Rep. Suzanne Schreiber, the law aims to recruit and retain quality teachers by alleviating childcare costs, supporting small businesses and enabling parents to work. The bipartisan effort, backed by key legislators like Speaker Kyle Hilbert and Sen. Chuck Hall, addresses Oklahoma's childcare shortage, which has seen over 4,300 slots lost in the past year. The state faces significant childcare challenges, with 55% of its population in childcare deserts and high costs consuming up to 32% of a single parent's income. This legislation is a step toward stabilizing the childcare sector and boosting workforce participation.
